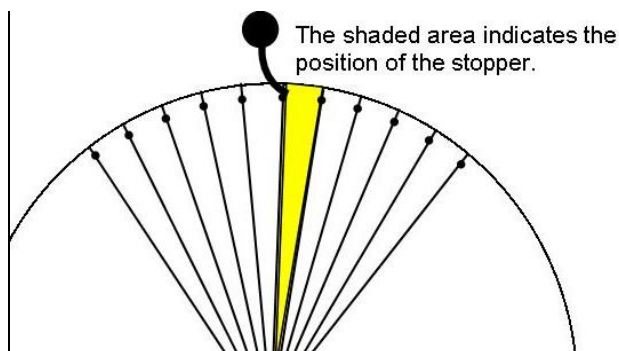


TERMS AND CONDITIONS

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to all current financial members. Members register in the Club Foyer between the hours of 6pm to 8pm and will be issued with an entry ticket.
3. Employees and Management Committee of the Promoter, participating retailers and agencies associated with this promotion are ineligible to enter.
4. The Promoter reserves the right, at any time, to verify the validity of the winners (including a winner's identity, age and place of residence) and to disqualify any winner who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
5. Incomplete, indecipherable or illegible entries will be deemed invalid.
6. If there is a dispute as to the identity of a winner, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
7. Three members will be randomly drawn between 6pm and 9pm.
8. There will be 100 panels on the wheel with 100 cash prizes ranging from \$100 through to \$30,000.
9. There will be no 5 x \$100 consolation draws as there has been in the past.
10. The draws will continue until three members have been found to spin the wheel per night.
11. Winners must be present to claim the prize, must be a current financial member of the Club and present their ID.
12. The winners will have 2 minutes within which to present themselves to the prize draw. If the winner does not make the draw aware of their presence within 2 minutes they forfeit their prize and a redraw will commence immediately.
13. All prize draws are broadcasted live on the Club's in-house television system and are also recorded for prize validation and general security. By entering this promotion you are agreeing to be filmed for these purposes.
14. Once a winner is found they have the chance to spin the wheel to reveal their prize. The wheel must make at least one complete rotation to be a valid spin. The number on the wheel is matched to the number on the prize board to determine the cash prize. Once a prize amount has been won it will be replaced with a 'Spin Again' before the next entrant spins.
15. The position of the stopper is determined by the location of the bottom tip of the stopper, as per the diagram below. If in doubt, the stopper will automatically be allocated to the panel on the right side of the spoke it is in contact with.

16. Any interference to the wheel or the draw process by anyone in any manner will result in an invalid spin and the member must spin again.
17. The Promoter's decision is final and no correspondence will be entered into.
18. All cash prizes can be taken up to the value of \$2,000. Any amount over \$2,000 will be issued as a cheque the following day.
19. If the prize (or any part of the prize) is unavailable, the Promoter, in its discretion, reserves the right to substitute the prize (or that part of the prize) with a prize of the equal value and/or specification.
20. Prizes, or any unused portion of a prize, are not transferable or exchangeable and cannot be taken as cash.
21. Entrants consent to the Promoter using the entrant's name, likeness, image and/or voice in the event they are a winner (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting this competition (including any outcome), and promoting any products manufactured, distributed and/or supplied by the Promoter.

If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) to modify, suspend, terminate or cancel the promotion, as appropriate.

Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of the prize.
24. As a condition of accepting the prize, the winner (and any companion/s) must sign any legal documentation as and in the form required by the Promoter in its absolute discretion including but not limited to a legal release and indemnity form.

The Promoter may, for an indefinite period unless otherwise advised, use the information for promotional, marketing and publicity purposes including sending electronic messages or telephoning the entrant.
